- IV. Jacob's Place Annual Report John Wetherell
 - a. Approval of the 2019 Jacob's Place Meeting Minutes
 - i. Jolene moves to approve the minutes as presented. Jill seconds. **Approved**.
 - b. The audit had a good result. If the chapter would like a copy, the chapter could have a copy. Skeet would like a copy for the records. Andrew will give an electronic copy to Skeet.
 - c. Facility inspection by HUD Iowa Finance Authority does this. It was done in May of 2020. The final report from the IFA had a minor exception but there was a satisfactory conclusion.
 - d. Tax return has been filed.
 - e. Capital expenditures Andrew Lynner and Eric Lynner with comments from Amy Garcia about the Covid 19 pandemic and what has been done with results to date regarding remediation efforts.
 - i. Above budget actuals are above what they budgeted for.
 - ii. Capital expenditures biggest is a new roof in the spring. \$177,000. Carpet and vinyl replacement, appliances, etc. Every

- month there is a contribution to capital reserves. (About 10,000 a month.)
- iii. Just finished replacing all of the fan coil units over 10 years. Jacobs place is demographically elderly and disabled. Amy Garcia was hired this year.
 - 1. Amy started efforts in March. Always followed CDC guidelines. Masks, washing hands, signs, sanitizers, etc. Two positive cases in July and 5 in December and none as of right now. Doing well overall.
- f. 2020 Slate of Officers and Directors
 - i. Skeet Wootten came onto the board. 3 board members whose time expired were asked to stay.
 - 1. Skeet moves to accept the Jacob's Place Board of Directors. Leighton seconds. **Approved**.
 - ii. Jolene moves to accept Jacob's Place Officers. Seconded by Jill. **Approved**.
- g. About 80 people live at Jacob's Place. Jacob's Place was built around 1980.
- h. St. Paul's and Jacob's Place Relationship: Jacob's Place is an Iowa not-for-profit corporation. It must have chapter officers and members. The only "shareholder" or "member" is the Cathedral. There has to be an annual meeting of the members each year under Iowa law and this is what the meeting we are having now is. There used to be a member of St. Paul's on the board of Jacob's Place. The bi-laws also state that non-members of the cathedral parish can be on the board as well.
- V. Approval for nomination for Vocational Diaconate Jean
 - a. If Chapter approves it they will need to complete a form.
 - i. All of this can be done through docusign.
 - b. Stephanie moves to approve and Elvin seconds. **Approved**.

 - a. All of our bills are paid. John does a great job. We have money in the bank and money in the transfer fund that we will carry over into next year. All things considered we are in a good place.
 - b. We will not need our 4th quarter draw from endowment. This is great news. We might need 4 or 5 thousand dollars but it keeps more money in the endowment fund.
 - c. We are down substantially on plate offerings. We are doing a good job keeping up with pledge payments.
